## Do I need to take special precautions?

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. Your water comes from 3 ground water sources.

## Why are there contaminants in my drinking water?

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity including:

microbial contaminants, such as viruses and bacteria, that may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife; inorganic contaminants, such as salts and metals, which can be naturally occurring or result from urban stormwater runoff, industrial, or domestic wastewater discharges, oil and gas production, mining, or farming; pesticides and herbicides, which may come from a variety of sources such as agriculture, urban stormwater runoff, and residential uses; organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban stormwater runoff, and septic systems; and radioactive contaminants, which can be naturally occurring or be the result of oil and gas production and mining activities.

In order to ensure that tap water is safe to drink, EPA prescribes regulations that limit the amount of certain contaminants in water provided by public water systems. Food and Drug Administration (FDA) regulations establish limits for contaminants in bottled water which must provide the same protection for public health.

# WATER QUALITY TABLE

The table below lists all of the drinking water contaminants detected during the calendar year of this report. Unless otherwise noted, the data presented in this table is from testing done in the calendar year of the report. ## Special Education Statements

### Additional Information for Lead

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. PWS system is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. We are required to test your water regularly for signs of microbial contamination. Positive test results could lead to follow-up investigations called assessments and potentially the issuance of public health advisories. Assessments could lead to required corrective actions. ## Significant Deficiencies

*Sanitary deficiencies are defects in a water system's infrastructure, design, operation, maintenance, or management that cause, or may cause interruptions to the "multiple barrier" protection system and adversely affect the system's ability to produce safe and reliable drinking water in adequate quantities.*

### Deficiency Title: Overflow Protection

Date Identified: 4/16/2019 Overall Due Date: 9/30/2019

Deficiency Description: The tank's overflow (ST001) has had a screen to keep out insects and rodents. The screen has failed, and the interior of the tank is vulnerable to access by insect, rodents and other vermin. Due to the slope and diameter of the overflow pipe, it is particularly vulnerable to water-seeking insects and animals.

Corrective Action Plan: The overflow should be protected with a sturdy screen that can protect against animals and insects. A weighted flap gate would also suffice if it seals well enough to keep out insects. Both a screen and flap gate are often used to ensure protection.

### Deficiency Title: Hatch Cover Gasket

Date Identified: 4/16/2019 Overall Due Date: 9/30/2019

Deficiency Description: The hatch cover gasket at a tank needs to be repaired or replaced.

Corrective Action Plan: The gasket should be repaired or replaced.

### Deficiency Title: Cross-Connection to the Reclaim Tank

Date Identified: 4/16/2019 Overall Due Date: 9/30/2019

Deficiency Description: The spent filter backwash water storage tank is not maintained as a finished water tank and, therefore, has openings that would allow the entry of contaminants. This is not currently an issue because the spent filter backwash water is not recycled. However, recycle facilities are in place and recycle is an obvious possibility. Additionally, the tank is cross-connected to the spent filter backwash water line.

Corrective Action Plan: Should recycle of spent filter backwash water ever be considered, the tank should be properly sealed, drained and cleaned prior to implementation of recycle. Until that time, EPA recommends that a vacuum breaker be placed on the spent filter backwash water line.

## Public Notice for Monitoring/Reporting and Other Violations

We are required to monitor your drinking water for specific contaminants on a regular basis. Results of regular monitoring are an indicator of whether or not our drinking water meets health standards. During the period covered by this report, we did not complete all monitoring or testing for the contaminants listed below, and therefore cannot be sure of the quality of your drinking water during that time. Violations which have not been returned to compliance will be repeated annually. The table below lists the contaminants we did not properly test for or other violations during the report period.
